INTRODUCTION

- ▶ Acquire skills and technical ability to understand and successfully mitigate problems relating to sustainability of the environment with special reference to Sri Lanka.



ADMISSION REQUIREMENTS

- (i) A Bachelor's degree from a recognized University/ Institution in Environment Management; OR
 - (ii) Any other Bachelor's Degree, with prior learning/ work experience in Environment Management; OR
 - (iii) Postgraduate Diploma (SLQF 8) from a recognized University/ Institution or an equivalent qualification acceptable to the Faculty Board and the Senate of the University with prior learning/ work experience in Environment Management; OR
 - (iv) Professional qualification in Environment Management from a recognized professional body which is acceptable to the Faculty Board and the Senate of the University with prior learning/ work experience in Environment Management; OR
 - (v) Completion of NVQ Level 7 (Equivalent to Bachelor's degree in SLQF) with relevant work experience in Environment Management as determined by the Faculty Board and the Senate of the University; AND
- ☑ A good knowledge of English language and satisfactory performance at a selection test and/ or a selection interview.
 - ☑ Each application under clause (v) shall be considered on its merit.
