The IBMBB will entertain applications from suitably qualified persons for the above post up to 06<sup>th</sup> March 2017.

**Educational Qualifications:**

1. A Special Degree in Immunology/ Special Degree in Biological Science with Immunology as a course unit with First or Second Class (Upper Division) Honours;

OR

2. A Special Degree in Immunology/ Special Degree in Biological science with Immunology as a course unit with a Second Class (Lower Division) Honours;

OR

3. A pass in the Special Degree in Immunology/ Special Degree in Biological Science with Immunology as a course unit;

OR

4. A pass in the BSc General Degree Examination or equivalent with a recognized Postgraduate qualification in Immunology

**Age:** Not more than 45 years

**Note:**

- (a) An applicant who is eligible under (4) above could be considered for appointment only if no applicant is qualified under (1) , (2) or (3) above.
- (b) An applicant who is eligible under (3) above could be considered for appointment only if no applicant is qualified under (1) or (2) above
- (c) An applicant who is eligible under (2) above could be considered for appointment only if no applicant is qualified under (1) above.

**Salary and Other conditions of Appointment:**

You will be placed on the appropriate salary point of the salary scale applicable to the Post Scientific Assistant, Grade II which is [U-AS 1 (I)]: as at 01-01-2020 Rs. 47760 – 19x690 – 60870 p.m. and you will be placed on the initial salary point of salary scale of Rs. 34,062 – 19x 492-43,410 p.m. in year 2017.

However, the following salary scales will be applicable to you until 2019.

Rs. 38,628 – 19x558 - 49,230 p.m. as at 01.01.2018

Rs. 43,194 – 19x624 - 55,050 p.m. as at 01.01.2019

In addition, you will be paid other allowances applicable to the post.

**Other benefits:**

- University Pension Scheme - Contribution by the employer an amount equivalent to 8% of the salary to the Universities Pension Scheme
- Universities Provident Fund - Contribution by the employer an amount equivalent to 7% of the salary to the Universities Provident Fund - Contribution by the employee an amount equivalent to 10% of the salary to the Universities Provident Fund
- Employees Trust Fund - Contribution by the employer an amount equivalent to 3% of the salary to the Employees Trust Fund
- Cost of Living Allowance - Rs. 7800/- per month (as per present regulations)
- Other Allowances approved by the Government
