APPLICATIONS are hereby invited from among those persons who are permanent residents of the authority areas of Pujapitiya Pradeshiya Sabha, in order to recruit to the vacant post in the Pujapitiya Pradeshiya Sabha, in the Central Province Government Service.

02. Method of Recruitment:

(i) Applicants should face an interview and the suitable candidate will be selected after scrutinizing the qualifications.

03. Terms of Employment:

- (i) The post is permanent and pensionable. Contribution should be made to Widow's/Widower's and Orphan's Pension Scheme.
- (ii) The general terms related to the Government Service recruitments shall be considered.
- (iii) These appointments will be subjected to a period of probation for 03 years. If the service, conduct and the attendance were found unsatisfactory within the probation period of service, the appointment will be terminated.

04. Other General Conditions:

- (i) The age limits is not less than 18 years and not more than 45 years at the closing date of applications. (Upper age limit will not applicable to the applicants those who are presently employed in Government or a Local Government institution).
- (ii) Applicants should be citizens of Sri Lanka by descent or by registration.
- (iii) Applicants should have an excellent moral character and physically sound, should face a medical examination conducted by a Government medical personnel within a month of appointment. If the physical condition is found not suitable, the appointment will be cancelled.
- (iv) Should not have been convicted by a Court of Law under Penal Code.
- (v) Should establish most immediate 03 years of permanent residency within the authority areas of Pujapitiya Pradeshiya Sabha to the closing date the applications are accepted. (Residency should be proved by the Voter's Register or the certificate issued by the Divisional Secretary).
- (vi) Should not be a person dismissed from the Government or Provincial Government Service.
- (vii) Applicants already serving in Government or Provincial Government Service have not been subject to any inquiry on disciplinary ground (except admonishment) and should be earned all salary increments for 05 consecutive years prior to the closing date of applications. If selected, further contributions should be made to the Widower's and Orphans Pension Fund Scheme.

- (viii) In addition to the terms and conditions of recruitment, appointees should comply with regulations of Establishments Code, the Financial Regulations, orders from the Government Departments and the orders that may be laid down from time to time by Central Provincial Government and the Pujapitiya Pradeshiya Sabha.
- 05. *Method of Application*.- Applications prepared according to the specimen given below, should be sent under registered cover, to "The Secretary, Pujapitiya Pradeshiya Sabha, Pujapitiya", on or before 12.06.2017. The post applied should be marked clearly on the top left hand corner of the envelop enclosing the application. (Those person who is already serving in Government Service, should send their applications through their respective heads. All applications should be prepared on papers similar size to A4 sheets) incomplete and delayed applications will be rejected.
- 06. The applications should be enclosed with copies of the following documents. First copies should be produced at the interview:
 - (i) Certificate of Birth,
 - (ii) Certificates of Educational Qualifications,
 - (iii) Certificate of residence, issued by the Divisional Secretary,
 - (iv) Two recent character certificates (one should be issued by the Grama Niladhari of the Division),
 - (v) Service certificates (only who serves already in Government Service).
- 07. The Secretary to the Pujapitiya Pradeshiya Sabha reserve all such powers to delay or alter such recruitment or cancel or amend this notification after calling applications or during such process.
