Applications are invited from eligible Sri Lankan citizens for the vacant positions of **Senior Policy Research Officer (01) and Development Officers (02)** of the National Education Commission.

01. Main Duties and Responsibilities entrusted to the posts

Senior Policy Research Officer

- Planning and guiding of educational research/surveys related with the field of education as decided by the National Education Commission and take leadership in educational policy formulation.
- Assisting the Chairman, Vice Chairman (Policy), Vice Chairman (Planning) and the Secretary in respect of educational policy formulation process.
- Monitoring the duties of the relevant Policy Research Officers and Programme Officers.

Development Officer

- Assisting the educational policy formulation, reviewing and research/surveys conducted by the National Education Commission.
- Collecting necessary information and data for the documents formulated by the National Education Commission and preparation of analyzed reports.

02. General Qualifications

- (i) The applicant should be of excellent moral character.
- (ii) Should be a person who is not convicted or penalized under the Penal Code by a Court of Justice.
- (iii) Senior Policy Research Officer The age should not be less than 30 years and not more than 55 years.
 - Development Officer The age should not be less than 22 years and not more than 45 years at the closing date of application.
 - (This age limit is not applicable for the applicants those who are in State / Corporations / Statutory bodies)

03. Service Conditions

These posts are permanent and entitled for EPF and ETF. The appointments are subject to three years' probationary period from the date of appointment. All the rules and regulations already imposed or to be imposed by the Government time to time are applicable.
