Applications are invited from eligible citizens of Sri Lanka to fill vacancies in the post of driver existing in Provincial offices of the Dept. of Animal Production & Health.

1. Designation - Grade III - Combine Driver Service

2. Salary Step - PL3-2016

Monthly Salary Scale - Rs. 25,790-10x270-10x300-10x330-12x350-38,990/=

(This salary scale is applicable with effect from 01.01.2020 and till then salaries will be prepared as per the schedule 11 of Public Administration Circular No. 03/2016)

Qualifications

1. Age Limit - Should not be less than 18 years old and not more than 45 years old. Maximum age limit is not applicable to those who are already in the Permanent and pensionable post in the Govt. Service.

2. Educational Qualifications - Should have passed G.C.E (O/ L) Examination in six subjects in not more than two sittings with two credit passes including Sinhala/Tamil.

3. Professional Qualifications - 1) Should have obtained driving license issued by the Commissioner General of Motor Traffic to drive private/hiring vehicles and Station Wagons which are less than 24 cwt in tar.

(Should possess a 'C' class and 'C1' class license or according to the new driving license a 'B' class license.)

2) Should have a sound knowledge in Highway Code.

4) Experience - Should have a three year experience as a driver of a vehicle. (This fact should be supported by certificates with the time period)

5) Physical Condition - 1) Should be at least 5 feet in height.

2) Should be physically fit and have a clear vision to work day and night and should be proved by medical certificates issued by a Govt. Medical Officer.

6) Other Qualifications 1) Should be a citizen of Sri Lanka

2) Should be of excellent character

- 3) Should have fulfilled all qualifications in every respect required for the recruitment for the post as at 22/04/2019.

❖ **Mode of Recruitment**

Recruitments will be made through a practical test and a general interview.

Syllabus for the practical test is as follows.

Subject	Maximum Marks	Pass Marks
(i) Driving Proficiency	40	20
(ii) Practical knowledge in road rules	40	20
(iii) Basic knowledge in Motor Mechanics	40	20

- Interview – Basic qualifications for recruitments will be scrutinized.

❖ **Conditions of Service**

1. Selected applicant will be subject to policy decisions taken by the Government in the future in respect of the pension scheme.
2. It is compulsory to serve at least 03 years in the office to which the officer gets the first appointment. However, the appointing authority reserves the right to transfer any officer before the end of the compulsory service period on specific circumstances.

Applications prepared as per the given specimen form should be sent by registered post to the Director General, Dept. of Animal Production & Health, P.O.Box 13, Gatambe, Peradeniya on or before 22/04/2019. If the applicant is already employed in the government service, application should be sent through the respective head of the Institute. Applications those receive after the closing date, incomplete and which have not fulfilled required qualifications as per the notification will be rejected.
