01. General Conditions of Recruitment :

- 1. Applicants should be citizens of Sri Lanka by descent or by registration.
- 2. Applicants should be permanent residents of the authority areas of Patha Dumbra Pradeshiya Sabha and should establish a period of minimum 03 years permanent residency prior to the date of calling application.
- 3. Age limits is not less than 18 years and not more than 45 years at the closing date of applications.

- 4. The recruitment will be made according to the recruitment procedure under merit order of the achievement of highest marks scored in the structural interview who possess all qualification required.
- 5. The Secretary to the Patha Dumbara Pradeshiya Sabha reserves all such powers to delay or alter such recruitment, replace or do amendment to the notification after calling application or during such process.
- 6. The applicants those who are presently serving in the Patha Dumbara Pradeshiya Sabha should forward their applications through their head of the Institution.

02. Terms of Employment :

- 1. These posts are permanent and pensionable.
- 2. Contribution should be made to Widow's, Widower's and Orphan's Pension Scheme.
- 3. These appointments will be subjected to a period of probation for three years and those who are in Government service will be subjected to one year period of probation.
- 4. Should abide to the provisions of the implementation of Official Languages policies and the implementation of the provisions of Official Languages Act, were in force and complied such provisions in future.
- 5. In addition to the terms and conditions of recruitment, appointees should comply with regulations of Establishment Code of the Republic of Sri Lanka, Central Provincial Council or the orders that may laid down from time to time by the Public Service Commission, Central Province.
- 6. Applicants should have an excellent moral chracter and be physically sound. If selected, should face a medical examination conducted by a Government medical personnel within a month of appointment. If the physical condition is found not suitable, the appointment will be cancelled.
- 7. Should not have been convicted by a Court of Law under Penal Code.
- 8. Should not be dismissed by the Government or Provincial Public Services or should not be a pensioner, retired under 44/90 Public Administration Circular.

03. *Method of Application.*– Applications prepared according to the specimen given below on 8.27" x 11.69" sized paper (A4), in the announcement should be sent on or before 11.10.2019 to the "Secretary, Patha Dumbara Pradeshiya Sabha, Pityegedera, Wattegama" under registered post.
