### Recruitment to the Post of Legal Officer on Contract Basis - 2021

Applications are invited from the citizens of Sri Lanka who have fulfilled the qualifications in this notice to fill the vacancy in the post of Legal Officer (on contract basis) in the State Ministry of Pharmaceutical Production, Supply and Regulation.

#### 01. Method of recruitment

The candidate who obtained maximum marks from an interview for evaluating eligibility conducted by an interview panel appointed by the Public Services Commission out of candidates who have completed qualifications mentioned in this notice will be recruited for the vacancy on contract basis. The interview for Evaluating Eligibility will be held in conformity with the marking scheme (given under No. 6) approved by the Public Services Commission. The effective date of the appointment will be decided by the Public Services Commission.

#### 02. Required Qualifications

##### (i) Educational/Professional Qualifications :

Should have sworn in as an Attorney-at-Law in the Supreme Court.

##### (ii) Experience :

Should have obtained an active professional experience not less than three (3) years subsequent to swearing in as an Attorney-at-Law in the Supreme Court. (The documents submitted in proof of the active professional experience should clearly indicate the period of experience, date and official frank and should be produced at the interview)

##### (iii) Physical qualifications:

Every candidate should be physically and mentally fit to serve and to perform duties of the post in any part of Sri Lanka.

##### (iv) Other qualifications :

- Should be a citizen of Sri Lanka,
- Should be of excellent character,
- Requisite qualifications for this post should have been completed in every aspect as at the closing date.

#### 03. Service occupying conditions and service conditions:

- This is a post created on contract basis and the holder is not entitled to a permanent appointment or privileges entitled to permanent officers.
- Shall contribute to the Public Service Provident Fund after being recruited to the post.
- This appointment will be subject to terms and conditions in the guidelines of Public Services Commission, Establishment Code of the Democratic Socialist Republic of Sri Lanka, Financial Regulations of the Government of Sri Lanka, and other Departmental Regulations.
- The later change of applied language medium will not be allowable, and the qualifying language medium for your appointment will be the language medium indicated by you in the application.

#### 04. Age Limit

Shall be not less than 21 years and not more than 45 years as at the closing date of the applications.

#### 05. Salary Scale

Monthly allowance – Rs. 47,615/- + Cost of living allowance – Rs. 7,800/-

Only the applicants who have submitted fully completed applications in every aspect will be invited for the interview for evaluating eligibility. Original copies of all certificates and duly certified copies should be submitted at the interview.

- Valid National Identity Card issued by the Commissioner of the Department of Registration of Persons;
- Valid passport.

#### 08. Submission of applications

- Specimen of the application is given at the end of this application. Applications should be prepared in A4 size papers indicating No. 01 to 03 in the first page, 04 to 06 in the second page and 07 to 08 in the third page and should be completed by applicant's own handwriting.
- "Recruitment for the post of Legal officer on contract basis" should be clearly mentioned in the top left corner of the envelope enclosing the application.
- Applicant's signature placed in the application should be attested by a principal of a government school /Justice of Peace/ Commissioner of Oaths /Attorney at Law/ Notary public/A Commissioned Officer of the Tri-Forces or an officer holding a permanent post in public or provincial service, earning a monthly consolidated salary of Rs. 47,615/-.
- Those who are in public service or provincial service at present should forward their applications through the heads of their respective Departments.
- Applications not in conformity with the specimen herewith will be rejected. Any complaint regarding loss or delay of the application will not be accepted.

#### 09. Furnishing false information

Your candidature is liable to be cancelled if it is found before recruitment that any information furnished by you in your application is false or incorrect. If it is found after the recruitment that you have furnished information that is false or incorrect you will be liable for dismissal from the Public Service subject to the relevant procedure.

#### 10. Public Services Commission reserves the right to fill the vacancy or not.

#### 11. If any inconsistency between Sinhala, Tamil and English texts of this Gazette Notification occurs, the Sinhala text will prevail.

#### 12. Any matter not provided for in this Notice or any problem regarding the recruitment procedure arises, the decision taken by the Public Services Commission shall be final.
