#### 1. Research Professor (On Contract):

**Project : Condensed Matter Physics & Solid-State Chemistry** 

**Qualifications:** The candidate should have a first Degree preferably with a first class or upper second class in Physics and also have a Ph.D. in Experimental Solid-State Physics/Condensed Matter Physics / Material Physics or related discipline with a sound knowledge of Chemistry and a minimum of 15 years of post-doctoral research or research and teaching experience.

**Job Description:** The Condensed Matter Physics and Solid State Chemistry Division currently has several ambitious projects on the development, synthesis and characterization of technologically important novel solid and quasi - solid polymeric materials with potential applications in nanofiber water filters for bacteria and arsenic removal, rechargeable batteries, dye sensitized and thin film solar cells and electro chromic display devices. The candidate is expected to play a leading role in strengthening these ongoing research programs.

#### **Project : Plant Taxonomy and Conservation**

**Qualifications**: The candidate should have a first degree preferably with a first class or upper second class in Plant Sciences / Agriculture and also have a Ph.D. in the Plant Sciences or related discipline and a minimum of 15 years of post-doctoral research and teaching experience.

**Job Description :** The applicant is expected to contribute significantly in one or more of the following areas :

- Development of the NIFS Arboretum in Dambulla
- Contribute to existing research projects on Forest Ecology at the NIFS
- Medicinal plants and natural products in Sri Lanka
- Taxonomy, Biodiversity Conservation and Restoration Ecology in a broad sense.
