3. OTHER BENEFITS

- The holder of the post of Bursar will be eligible for sabbatical leave in terms of the existing regulations. The holder of the above post is entitled for an assigned vehicle with b)
- the approved fuel allowance. Gratuity payment will be in accordance with the provisions of the
- Payment of Gratuity Act No. 12 of 1983.
- The selected candidate will become contributors to the Universities Provident Fund and Universities Pension Scheme in terms of the existing regulations. The appointee is required to contribute 10% of the monthly salary to the Provident Fund while the employer will contribute a sum equivalent to 15% of that salary of which 8% is credited to the Pension Scheme, 7% to the Provident Fund and 3% to the Employees Trust Fund.

The employees who will not be able to serve twenty years or more in the University System from the date of appointment to

the compulsory age of retirement (Non-Academic -- 60 years) will not be contributed to the Universities Pension Fund and such employees will not be a member of the Universities Pension Fund. The appointment will be on probation for a period of three years

which may be extended at the discretion of the Council of the University of Colombo. Provided that, where an employee confirmed in the Commission

or in a Higher Educational Institution, is subsequently appointed for the said post, in the first instance, be for a probationary period of one year, and shall thereafter be subject to confirmation by the Governing Authority of the University of Colombo.
