Qualifications required

G.C.E. (A/L) examination in at least two subjects with six years' experience in the relevant field.

OR

2. G.C.E. (O/L) examination in six subjects in not more than two sittings or equivalent with 10 years' experience in the relevant field of which two years should be in supervisory capacity.

AND

- Should pass a written test and / or Trade test. 3.
