- This post is permanent and sans the pensions, entitled to contribute 10% of the salary by the employee and 12% of the salary by employer, to the Employees Provident Fund (EPF) and 3% of the salary to the Employees Trust Fund (ETF) by the Employer.

Those who are already employed in the Public Service will be recruited under the secondment basis and the period of the duration of service of the post will be decided by the Authorizing Officer of the appointments, subject to performance of the Officer concerned.
