Qualifications - **Manager (Plantations)**

(a) External Candidates

1. A Bachelor's degree in Science/ Agriculture/ Business Administration / Business Studies / Business Management / Plantation Management / Management / Commerce which is recognized by the U.G.C.

AND

A minimum of one year post qualifying experience in the post of Manager (Estate) / Superintendent in a Regional Plantation Company, SLSPC or JEDB after obtaining the first degree.

(b) Internal Candidates (1 or 2 below)

1. Having obtained the qualifications required by the external candidates above.
 2. Completion of minimum five (05) years satisfactory service in a post of Assistant Superintendent / Asst. Manager - Plantation (JM Category), in Sri Lanka State Plantations Corporation

Salary Scale - As per the Management Service Circular 02/2016 a Salary Scale of M M 1-1 - 2016 Rs.[53,175-- 10 x 1,375- 15x 1,910 - 95,575] is entitled for the above Post.

Age - Should not be less than 22 years and not more than 45 years. The upper Age limit will not apply to internal candidates.
