- Having obtained fellowship from a recognized professional Gemmological Institute and minimum of 05 years post qualifying experience in a reputed Gem Testing Laboratory. Having obtained Diploma in Gemmology and 10 years post qualifying
- experience in a reputed Gem Testing Laboratory. Having obtained two years part time certificate course in Gemmology 5 from a recognized institute and minimum 12 years post qualifying

Age - Should be not less than 22 years and not more than 45 years. (Before the closing date of applications) However, the upper age limit would not apply to internal candidates.
