- A graduate of a local or foreign University recognized by University Grants Commission of Sri Lanka with at least 2<sup>nd</sup> class Lower division /2<sup>nd</sup> class Upper division/ First Class degree or Grade Point Average (GPA) with a minimum of 3.0 out of a maximum of 4.0 points obtained in subjects/ disciplines of Information Technology, Information Security or any other relevant area identified in the Information Technology sphere.

#### METHOD OF SELECTION

Shortlisted applicants based on the stipulated qualifications will be called for a structured interview conducted by the Bank. The interview will be conducted to verify whether the applicant has satisfied the minimum eligibility criteria mentioned in the newspaper advertisement and ascertain as to whether the candidates have the necessary Technical Knowledge, Skills regarding Information Technology and related services. The selection will be made on the order of merit basis. The appointment will be made on a two-year fixed-term training contract basis and performance will be evaluated annually.
