1. A Bachelor's degree in Agriculture / Plantation Management, which is recognized by the U.G.C.

 Followed a training period for 9 months as a Planter Trainee (Creeper) in a Regional Plantation Company, SLSPC or JEDB
 2. Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 6 in the field of Tea Plantation issued by a technical/ vocational training institute/ National Institute of Plantations Management accepted by the Tertiary and Vocational Education Commission.

 At least five (05) years post qualifying experience in a relevant field in a Corporation, Board, Regional Plantation Company, or a Reputed Statutory Institution
 AND
 Followed a training period for 9 months as a planter trainee (creeper) in a Regional Plantation Company, SLSPC or JEDB
 3. Having an experience not less than 3 years as an Assistant Superintendent in Organizations of Government/ Semi Government or a recognized Regional Plantation Company.
- Extra Benefits** - Facilities under Indoor and Outdoor Medical Insurance Scheme.
 Contribute to the Employees' Provident Fund or to the Ceylon Planters' Provident Society a minimum of 10% of your salary to such Provident Fund and the SLSPC contribution to such Provident Fund will be a maximum of 12% and 3% to Employee's Trust Fund of your salary.
 A supervising motor cycle or an allowance and a fuel quota will be provided.
