## SMALLHOLDER AGRIBUSINESS AND RESILIENCE PROJECT (SARP)

## **Vacancies**

The Smallholder Agribusiness and Resilience Project (SARP), a project jointly financed by the International Fund for Agricultural Development (IFAD) and Government of Sri Lanka, aims to build resilience and market participation of 40,000 rural households in the climate change affected districts of Anuradhapura, Vavuniya, Matale, Mannar, Puttalam and Kurunegala. This is pursued through capacity building for climate resilience and inclusive value chains, combined with investments for climate resilience and inclusive value chains including last mile infrastructure. The lead programme agency is the Ministry of Agriculture, which would be established a dedicated Project Management Unit (PMU) at central level and two regional hubs the implementation of SARP. Total project finance value is USD 82 Mn.

Applications are invited from citizens of Sri Lanka with below mentioned qualifications and experience to fill the following position for the Project Management Unit and the District Hubs.

## Senior Project Engineer (PS03) - 01 Position

### **Summary of Responsibilities**

The Senior Project Engineer of the SARP will be responsible for the planning and execution of the overall infrastructure related aspects of the project. He/she will review the designs and costing of various tank irrigation infrastructure, and help plan the construction activities, provide overall supervision of the construction of various infrastructure components planned under SARP in the respective districts.

government services will be recruited on contract basis. All appointments will be initially for a period of one year and extension of services will be based on successful performance.

Project Management Unit (PMU) is in Battaramulla. However, traveling to project locations are involved frequently.

The employee will be a member of the Employees' Provident Fund and Employee's Trust Fund and contributions would be made to the said schemes by the Employer and Employee in accordance with the relevant Acts.
